Subject: Notice to Cure Breach Reference: Agreement No. 4400005525

Dear Ms. Hollister:

We are writing to notify you that Vision To Learn ("VTL") is out of compliance with the terms of the abovereferenced agreement. The Los Angeles Unified School District ("District" or "LAUSD") considers VTL's lack of compliance as grounds for issuance of a Notice to Cure Breach ("Notice") and possibly termination for default under LAUSD Agreement No. 4400005525 ("Agreement").

As of the date of this letter, VTL is not on schedule to provide screenings, exams and glasses for 30,000 students in the 2017/2018 school year as is required under the Agreement.

Pursuant to Section 15, <u>Termination</u>, of the Agreement, VTL is hereby notified that unless the issues set forth below are cured (corrected) by May 10, 2018, LAUSD may terminate the Agreement for default.

Below is a discussion of events that necessitated this Notice.

According to the Agreement, VTL is required to provide screenings, exams and glasses for 30,000 students annually (i.e., for school year 2017-2018). As of today, our records indicate that VTL has screened only 1,572 students, 1,572 have received exams, and up to 1,387 may have received glasses. Because only three (3) months remain in the school year, it appears unlikely that VTL will be able to timely perform its obligations under the Agreement.

District school and Nursing staff received complaints of scheduling challenges and delays caused by VTL. Indeed, Exhibit A, Page 1, paragraph 6, item #7 states when an individual school has turned in 20+ consent forms, Contractor operations staff shall schedule a mobile clinic visit. However, numerous schools (with returned consent forms) dating as far back as Fall 2017 requested services have not been contacted, had their calls returned, or been scheduled for a visit. Parents of students are asking when their child will be seen by VTL. (See attached list of emailed complaints, titled Exhibit A, Item #7. Email complaints.)

Moreover, Exhibit A, Page 1, paragraph 6, item #8 states Contractor's mobile clinic shall come to the school on the date previously agreed to with school site Principal/Administrator. Yet, few schools have been contacted to set up a date. Furthermore, schools that have been contacted are being informed VTL will focus on conducting vision screenings for the remainder of this school year and will schedule the mobile clinic for **eye exams** beginning in the **2018-2019** school year. (See attached list for emailed complaints, titled Exhibit A, Item #8, Email complaints.)

In addition, Exhibit A, Page 1, paragraph 6, item #9 states trained opticians and doctors shall conduct exams for every student who fails the vision screening. Because of VTL's delays in scheduling, students who have failed the vision screening and will be matriculating to another school (i.e., 5th or 6th grade elementary students matriculating to middle school, 8th grade students matriculating to high school and 12th grade students who are graduating) may not receive exams or glasses. (See attached list for emailed complaints, titled Exhibit A, Item #9, Email complaints.)

In responding to this Notice, VTL is required to provide a plan of corrective action it will take to complete screening, exams and providing glasses for 30,000 District students by June 30, 2018. Please ensure this plan includes milestones for each action.

Failure to provide a viable plan by May 10, 2018 and/or, if a viable plan is provided, failure to implement the plan and complete the Year One services by June 30, 2018, may result in termination of the Agreement for default. This is the first time I am hearing this. Why is that?

Only 125 students will receive glasses. Why would we screen almost 900 who will not be there next year?

In emailing/speaking with Jessica, I stated that over 220 student day were referred and those students would be screened. (They have not been screened by us.) We discussed setting up dates for the following school year so that all 3200 students can be screened at the beginning of the new year.

Again, I had asked since September for screenings and my emails were left unanswered.

We are now in then midst of testing and do not have access to a room that will accommodate that many screenings, which is why I requested that this happen at the beginning of the school year.

Based on the limited number of students who will receive glasses, we sent notices to parents, teachers, and students asking for referrals. We have over 220 students who were referred. That may mean some of those students will be eligible for glasses and not receive them until next year, and some of them are seniors.

I hope this has clarified that we decided to focus on our students with the most urgent need. To deny them the opportunity for glasses because you'd like to screen several hundred students who will not be there next year would be an injustice.

Please let me know how this can be resolved. Otherwise, I will have to notify the 228 families that their child will not be provided this opportunity any more.

Hello,

I am looking for clarification. The first time we communicated, I was told that there was not enough time in the school year to test all students (even though I had requested this in August) and that only 125 students would be able to receive glasses. Because of this, we decided to screen only those who self referred, teacher referred, or parent referred. As of today, 200 consent forms have been distributed and 81 have been returned. I am not sure why testing for all students would take place now if some students would not receive glasses for 6 months. I would like to set up a date now for the entire campus for next year if that is possible.

Can I clarify what adjustable lighting looks like? Does lighting in a classroom not meet that criteria?

Additionally the Miller Career and Transition Center for special needs students ages 18-22 (which is across the street from us) asked if they could also participate. Do they have to request a visit separately?

These schools will take top priority in scheduling dates for next school year. The outreach for those schools listed will begin next week.

For all the schools who have not returned principle approval forms, my hope is that we will speak to those principles during the April 2nd meeting and follow up with the individually for scheduled dates next school year.

Lastly, for next school year, I hope to have a tentative schedule for all the schools who returned forms to be provided to you all in May. In the meantime, I will create a google doc. and share it with you all. This way you all can be updated in real time on the progress of schools in local district Northwest.

Please let me know if there is anything that needs adjusted or if there are any questions. Thank you all for your patience and I look forward to working with you all going forward.




